The FSR Act (Financial Services regulations Act Of 2017) changes to the FAIS Act and amendments that were required for a number of our financial services acts have resulted in a changed environment and new Fit and Proper requirements for representatives, key individuals and financial service providers.

As a financial advisor, keeping a record of advice is a vital part of the job. A debarment in terms of section 14(1) of the FAIS Act, means that the provider prohibits a representative who no longer complies with the fit and proper requirements from rendering financial services and removes his/her name from the register of representatives. The debarment prevents the representative from functioning as a representative of any provider, not only for the provider who brought ...

### **The reappointment process of a debarred representative**

The Financial Sector Conduct Authority (FSCA) has published a FAIS Notice which seeks to exempt certain Financial Services Providers and Representatives from the provisions of the FAIS Act. The Notice comes into effect on 1 February 2019.
